

## Tribal Enrollment and Genetic Testing Resources

When the NCAI Policy Research Center began developing this resource guide, tribal leaders asked many questions such as, "What is genetic testing? What are good sources of information about genetic testing? What kinds of DNA testing can we use for tribal enrollment? How do we respond to individuals claiming tribal membership based on DNA tests?" The resources below were developed to provide tribal leaders with more information on genetic testing related to tribal enrollment. Tribes are sovereign nations and so will decide their own views on genetic testing. These resources provide information to assist in those decisions.
